

RELEASE AND WAIVER OF LIABILITY OF DC CENTRAL KITCHEN

I the undersigned ("Volunteer") and dated below releases DC Central Kitchen, a nonprofit corporation organized and existing under the laws of the District of Columbia and each of its affiliates, partnerships, directors, officers, managers, employees, contractors, service providers, and agents. The Volunteer desires to provide various services as a volunteer for DC Central Kitchen and engage in various authorized activities related to serving as a volunteer for DC Central Kitchen.

Volunteer understands that the scope of Volunteer's relationship with DC Central Kitchen is limited to a volunteer position and that no compensation is expected or will be provided in return for services provided by Volunteer. Volunteer understands and acknowledges that they are not in an employment or any other contracted or service provider relationship with DC Central Kitchen other than on a volunteer basis. DC Central Kitchen will not provide benefits traditionally associated with employment by DC Central Kitchen. Volunteer further agrees and acknowledges that he/she is responsible for his/her own insurance coverage in the event of personal injury, accident, illness, or any other event requiring medical or health treatment as a result of Volunteer's services to DC Central Kitchen.

- 1. WAIVER AND RELEASE:** I, the Volunteer, release and forever discharge and hold harmless DC Central Kitchen and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to DC Central Kitchen. I understand and acknowledge that this Release discharges DC Central Kitchen from any liability or claim that I may have against DC Central Kitchen with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to DC Central Kitchen or occurring while I am providing volunteer services.
- 2. NO RIGHT TO COVERAGE FROM DC CENTRAL KITCHEN:** Further, I understand that DC Central Kitchen does not assume any responsibility for or obligation to provide me with compensation, remuneration or any other financial assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death, or damage to my property. I expressly waive any such claim for compensation or liability on the part of DC Central Kitchen.
- 3. NO CLAIMS FOR MEDICAL TREATMENT:** I hereby Release and forever discharge DC Central Kitchen from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with DC Central Kitchen.
- 4. ASSUMPTION OF RISK:** I understand that the services I provide to DC Central Kitchen may include activities that maybe hazardous to me including, but not limited to operation of kitchen appliances, use of kitchen instruments, use of cleaning products, operation of a motor vehicle, and other work involving inherently dangerous activities. As a volunteer, I hereby expressly assume the risk of injury or harm from these activities and Release DC Central Kitchen from all liability for injury; illness, death, or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
- 5. PHOTOGRAPHIC RELEASE:** I grant and convey to DC Central Kitchen all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by DC Central Kitchen in connection with my provision of volunteer services to DC Central Kitchen.
- 6. GOVERNED BY DC LAW/ENFORCEMENT:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the District of Columbia and that this Release shall be governed by and interpreted in accordance with the laws of the District of Columbia. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
